Cheryl Dinnell, Executive Director (ED)

- Still have vacancies on the NLRCC board.
- Still holding community respite bi-monthly meetings.
- Need to continually add new content to websites and social media sites.
- Unexpected delays with the social media one-minute video in development but are still moving forward with it.
- Cheryl has been representing NLRCC at national and state meetings.
- Cheryl will be attending the ARCH Conference in September 2022.
- Request to grant the Chair and/or Executive Director specific powers to act on behalf of NLRCC to respond to or provide recommendations on actions that could impact family caregivers.
- Workgroups needed to work on specific recommendations for inclusion in the State Plan development.
- Motion to have NLRCC Board grant powers to the Chair/Executive Director to act on recommendations or positional statements, letters of support and other timely requests for response and actions that tie into already established goals, responsibilities, priorities, and positions. - 5. Presentation and Discussion on Personal Care Aide (PCA) Services Regard the Populations and Agencies they serve

Chuck Duarte, Nevada Director of Advocacy and Public Policy, Alzheimer's Association

- Approximately 6 million people living with Alzheimer's or dementia in US.
- 11 million unpaid care givers in America valued at \$256.7 billion.
- Alzheimer's disease deaths have increased 145%.
- Alzheimer's disease affects gender and ethnic groups differently.
- Nevada has the third fastest growth in population of people with Alzheimer's.
- Alzheimer's is the most expensive disease.
- Nevada will need a 267% increase in geriatricians by 2050.
- Recommendation to review the <u>Guinn-Center-Helping-Hands-PCAs-Nevada.pdf</u> (<u>guinncenter.org</u>) was made.

- Nevada is ranked 1st in increase of senior citizens, prompting the need for additional PCA's. Demand outstrips supply and creates a Care gap.
- Other states have Family Caregiver Waivers that Nevada could adopt to strengthen families through support, training & pay as caregivers.
- Personal Care Policy Initiatives on workforce shortages, Medicaid rates
 & coverage, career path for direct care workers, competitive employment.
- It is not likely we will see an increase in Medicaid reimbursement rates.
- The average PCA makes \$11.00 an hour, the average respite caregiver makes \$9.75. Equalizing rates for respite needed.
- Medicaid reimbursement rates are \$17.00-\$18.50 hourly, unchanged for decade or more. Governor suggested flat budgets for next 2 years.
- Skilled by unskilled allows a trained PCA signed off by healthcare professional to perform some types of services. NRS 629.091
- Creating PCA career path with specialized training where Medicaid has tiered payments commensurate with the range of services in NRS.
- Colorado may have ability to get training to family and friends, around certain skills required to provide respite, waived from the nurse practice act.
- Two ways to hire family members. Either an PCA agency (who assumes all liabilities & requires training) hires them, or the Intermediary Service Organization (ISO) is the employer of record and issues a 1099 for workers' wages.

- 6. Presentation on the Foundation Assisting Seniors:

Carol Chapman, President, Foundation Assisting Seniors

- This twenty-year-old 501(c)(3) loans out durable medical equipment to people who need it in the Las Vegas area. Canes to hospital beds loaned for 90 days for free. Any equipment that is power operated will require a prescription.
- To qualify you need to be a veteran or 50 years old or older.
- A separate program provides light home maintenance, that includes changing lightbulbs, air filters, lubricate garage doors and other small tasks. All are volunteers and services are free.
- The "How Are You?" program is nationwide. Participants receive a call at 6:00am in the morning, if the answer the phone and press the #5 the system is notified the person is alright. If they do not answer, they will get two other call backs in that day. If none of the calls are answered, a supervisor will make a live call; if they still don't get an answer then a wellness check will be requested. It's a free service.
- Families can sign up their loved ones. Over 360,000 Nevada clients total have been served (approximately 30,000 each year).

- Hours of operation are Monday thru Friday 9:00am 12:00pm, with deliveries between 8:00am-1:00pm.

- 7. Presentation on Nevada Rural Counties Programs and Services, Retired and Senior Volunteer Program (RSVP)

Molly Walt, Chief Executive Officer, Nevada Rural Counties RSVP

- After 50-years this 501(c)(3) has up to 11 programs, depending on the county they are in.
- These help seniors and people with disabilities live independently.
- Transportation program is the most popular. Drivers become extended family.
- Home companionship spends time with the seniors and more. All programs emphasize companionship as part of the services.
- Respite Care Providers are paid & matched with clients with 2-4 hours a week.
- Homemaker service workers are paid and provide several chores services. This popular service has a waitlist.
- CARE Law services available, pro bono, for estate planning, guardianship, Medicare/Medicaid, and elder abuse.
- Volunteer Stations provide volunteers for a variety of services. Largest one is for Veterans Memorials. Mileage reimbursement is provided.
- Guardian 911 Alert Plus & Philips Lifeline are emergency response systems that RSVP offers.
- Farmers Market Coupons are distributed to low-income seniors. Worth \$45 for purchases at local farmers' markets.
- "Friends Day Out" Java Music Club is back in person in some counties (after COVID) where RSVP has found a venue to hold it at.
- "Good Neighbor" program conducts check-in-calls and other services depending on location. All volunteers are trained and are mandatory reporters. Volunteers also provide regular in-person visits.
- RSVP will be taking over the Nevada Ensures Support Together (NEST)
 Collaborative and all its programs, as of July 1st, statewide.
- 8. Lifespan Respite Updates:

Yazmin Orozco, Lifespan Respite Program Coordinator, Aging and Disability Service Division (ADSD)

- Still have some emergency respite funds from November 2021 funding. Additional funding of \$45K for emergency will be split between Southern & Northern Nevada, starting June 1st.
- 41 Family caregivers have received emergency respite assistance.
- ADSD & Community & State Partners working on standard satisfaction survey for use statewide. This data will be included in the ADSD Caregivers in Nevada report. This survey is available at <u>Caregiver Respite</u> <u>Satisfaction Survey (office.com)</u>.

- Recruiting efforts for respite workforce are being explored through respite training pilot project. Launched training in February 2022.
- 38 people have enrolled in the respite training pilot program; 11 have completed all 10 courses. This is a free training for future respite care workers.
