- AB78 Family Caregivers may be relieved of their role in dispensing medication if JDT programs can administer medication without a nurse.
- AB100 Family caregiver needs/capability to give care will be assessed so that resources can be offered to them as they provide care at home.
- AB116 Families are given information on Down Syndrome when a preterm or newborn diagnosis is made, so they are connected with resources and support as soon as possible.
- AB202 Allow family caregivers to be in communication with/monitor care of a care recipient, without being there in person, by electronic means.
- AB208 Family caregivers of certain care recipients would be able to become paid caregivers.
- SB156 Open Meeting Law public meetings, through remote technology, still need to protect full participation of people with disabilities.
