- 4. **Presentation and Discussion:** Informal Respite Options at JustinHope:
 - Job training and employment services have been identified as gaps in services.
 - This program allows caregivers to drop off individuals so they can learn training skills.
 - Individuals learn soft skills in small groups once a week.
 - The first Cohort launched 6 months ago with a revised Cohort being implemented developed from things that were learned from the first one.
 - The Empowerment Exchange is a networking event for individuals with intellectual disabilities (ID) and the community to interact and socialize while gaining insight on other job experiences.
 - The Empowerment Exchange meets in Northern Nevada once a month.

- Other activities/ partnerships are in place to help people with ID to educate and assist with life skills.

- 5. **Presentation and Discussion:** Healthcare Policy for the Frail Elderly (FE) & Physical Disability (PD) waivers
 - The purpose for respite services is to support the primary caregiver.
 - The Frail Elderly Waver (FE) provides 336 hours a year.
 - The Physical Disabilities (PD) waiver is 120 hours a year.
 - Hours can be used for several activities like doctor's appointments, vacations, or adult daycare to name a few.
 - Currently 4,300 recipients are being served.
 - The wait list has been cleared in Northern Nevada for the FE & PD waivers.
 - Southern Nevada is short on case workers and case managers so the wait list will remain.
- 6. **Presentation and Discussion:** NLRCC's Role with Caregiver Coalition's Caregiver Recognition Event in November North & South locations:
 - Dignity Health has offered a caregiver support program since 2015 called Powerful Tools for Caregivers (PTC). It is a 6-week workshop.
 - A virtual support group was added to accommodate caregivers during COVID.
 - In person support groups are now available in English and Spanish.
 - Pathways Hub was added in the past year, and it pairs caregivers with community health workers.
 - The 18th annual Caregiver Recognition event will be on November 16th, 2023, from 11:30 to 1:30. In Reno it will be held at South 40 and in Las Vegas it will be held at East Las Vegas Community Center.
 - Interested participants can register using the registration link.
 - There are three ways to participate. The information is available on the registration link.
 - 2022's event was a hybrid and had 300 attendees in Reno and 50 in Las Vegas. 94 caregivers were honored between the two locations.
