- Personal Care service cost \$25 an hour minimum 4 hours a week and these hours can not be broken up. It includes bathing, toileting, heavier house cleaning and they will run errands. Not transportation or overnight stays.

  - The Caregiver Support Coordinator that was going to start has filled a different role and a new recruitment will go out in the next couple of weeks.
  - The Nevada Centers for Excellence in Disabilities (NCED)have served 232 families with children with dual diagnosis.
  - NCED will be recruiting members for a steering committee in May 2025 to help inform the efforts of AB100's implementation, training and recruitment.
  - A vendor has been contracted to provide a respite training system, and it is expected to have some initial training that was developed a couple of years ago.
  - It is estimated to launch in June of 2025.
  - The Executive Director position has been posted, and a few resumes have come in and are in the review process.
