- 3. For Possible Action: Approval of NLRCC March 13, 2025, Meeting Minutes:

- 4. **Report and Discussion:** From 2025 Lifespan Respite Conference Attendees (Amy Dewitt-Smith, Molly Walt, Cory Lutz, Cheyenne Pasquale):
 - All agreed that the conference was organized, and very informative.
 - Great keynote speakers that provided beneficial information.
 - Breakout sessions were geared for seniors and independent living.
 - Ideas to potential use in the next fiscal year.
 - Navigating change and how to support each other during these tight times.
 - Sharing resources is going to be key in supporting each other.
- 5. **Review and Discussion:** Funding Reductions Relating to Funds for Healthy Nevada (FHN) Funding:

- Funds for Health Nevada are from tobacco settlement dollars that the state has had for a long period of time.
- These funds received a 12% cut across the board which for the Aging and Disability Service Division (ADSD) is approximately \$1,000,000 in funds.
- Tough decisions were made for fiscal year 2026.
- The Nevada 211 system also received a reduction that will have an impact.
- 6. **Review and Discussion:** Aging and Disability Service Division (ADSD) Report regarding Lifespan Respite Grants including AB100 the Implementation of a Pilot Program to Administer Certain Family Caregiver Assessments:

Cheyenne Pasquale, Planning Chief, Diana Rovetti, Senior Project Director and Diane Thorkildson, Assistant Director, Nevada Center of Excellence in Disabilities

- Lori Lutu will be taking over the day-to-day activities for the Lifespan Respite grants.
- Diane Thorkelson & Diana Rovetti from the Nevada Center of Excellence in Disabilities (NCED) will be the project manager and support.
- Assisting ADSD with the implementation of AB100 with the coalition being instrumental partners.
- Identifying data resources already available and coordinating the collection into one system. This will help identify respite resources and any gaps that need to be addressed.
- Plans to complete an evidence-based practice audit and find out how resources are being used.
- Possibility of forming a Steering Committee to shape and develop a practice manual outline with the expectations for the state of Nevada Respite care services.
- Funds for the Lifespan Risk Act are funded until September 30, 2025.
- Competitive notice of fundings for direct services for lifespan respite may go out in the next few months.

7. Review and Discussion: Legislative Updates:

- Assembly Bill (AB)337: Creates Programs related to Dementia.
 - Did pass through the Assembly and was referred to the Money committee.
- AB338: Revises provisions relating to Health Care for Seniors.
 - Referred to the Money Committee.
- AB461: Revises provisions governing Health Care.
 - In Work Session.
- Senate Bill (SB)78: Revises provisions relating to Boards, Commissions, Councils and similar bodies.
 - Was amended and declared exempt.
- General Budget Updates.
 - No budget enhancements were made this session.
 - No Caseload growth for the division.

- The economic forum report will be monitored closely to if the reduction in tourism and gambling income changes.
- 8. Review and Discussion: New Older Americans Act Title IIIE Funding
 - 4 awards will be implemented following the National Strategy Recommendations for family caregiver support.
 - The project is for a 24-month period for up to \$490,000.
 - It does have a 25% match based on the total project cost.
 - This funding has not been published yet.
 - The match requirement is a concern.
- 9. **For Possible Action:** Review and Approval of NLRCC Bylaws regarding Member Appointments:
 - Reduce the member count from 11-15 to 9-13.
 - Remove two members who are direct service workers or volunteers, providing temporary respite.
 - The Chair can remove those who are absent for at least two meetings during a calendar year with no communication.
 - Molly Walt motioned to approve the changes
 - Amy Dewitt-Smith second the motion
 - All approved
