4. Presentation on Nevada Lifespan Respite Care Coalition (NVRCC):
Cheryl Dinnell, Executive Director NLRCC
 - Respite is a short-term caregiver support that provides caregivers temporary breaks.
 - Data from AARP shows that 41.8 million people, or 16.8% of the population currently provides care for an adult over 50.
 - Only 3 in10 caregivers have additional help, and 27% struggle to find affordable care in their area.

- 1 in 4 caregivers find it hard to take care of their own health while caring for others.
- Having protective and emergency support services available and accessible to caregivers can help with the long-term services and supports system.
- When a gap in eligibility is created, the caregiver often takes on the additional burden without any kind of assistance.
- The administrative task is often left for caregivers to carry the burden.
- Care recipients often need assistance in managing finances, case management and care coordination.
- Providers are struggling to find qualified workers.
- 53% of caregivers feel like they have no choices.
- NLRCC will be looking into what Nevadans know about caregiving across the lifespan, what caregivers need, and what support is needed.
- Someone who is support or connection can be considered respite. It can be in or out of the home.

- Dementia Crisis Response in Community and Residential Care: Meeting with several organizations that have been involved in a statewide crisis intervention. Report back to TFAD as things progress.
- Healthy Brain Initiative: Research with potential stakeholders for these recommendations.
- Dementia Inclusion in Memory Care: Work with the Department of Behavioral Health (DPBH), Healthcare Quality and Compliance (HCQC), Aging and Disability Service Division's (ADSD) Chief Elder and Disability Rights Attorney and bring back what is being done as well as invite presenters to present to TFAD.
- Advanced Care Planning: Narrowing down the areas of focus and contacting legal, medical, and social services stakeholders. Looking at state specific terms for guardianship and when a healthcare power of attorney goes in effect. Early expectations are that more than one focus area will be attached to this recommendation.
- Cognitive Assessments and Diagnosis: Gathering a list of areas that cognitive assessments can be done (example: hospital discharges). Gathering data on annual wellness visits and their utilizations, potential home screenings and what level of evaluation can be completed statewide. Publicize and identify the locations that can perform the evaluations.
