• Have conversations with those who write legal service grants to include Advance Care Planning (ACP) within the grant structure.

- The need to educate legal professionals on signs of dementia so they can identify when meeting with clients.
- Need a distinction between medical and legal ACP needs.
- Educating consumers and having access to information & resources are some of the top needs to be address for ACP.
- Suggestions to educate Medicare & Medicaid participants about ACP along with flyer in doctors' offices that would cover medical ACP needs.
- Working with outside groups like AARP and Senior groups to encourage having the conversations with participants.
- The potential to add information to the Nevada 211 website.
- Some concerns with Physicians including ACP in a patients file are additional paperwork, legal ramifications/entanglements, and no way to enter it into their medical portal.
- Concerns with having ACP directive added to discharge papers is that it will just get lost in the files that get sent home and will not be completed.
- Hospitals are not able to provide one-to-one assistance with ACP forms.
