Jennifer Richards, Chief Rights Attorney, Aging and Disability Services Division (ADSD)

- Advance Care Planning in Nevada uses two versus:
 - Competency Legal Incompetence is a legal term that refers to an inability to make decision. A Judges makes this determination when a person is permanently impaired.
 - Capacity Medical -Is specific to the proposed medical intervention and may change over time.
 - o Competency is more aligned with criminal proceedings
 - Capacity under Guardianship is more in line with the medical needs
 - Physician's Order of Life Sustaining Treatment (POLST) patient's physician concerning end of life care.
- Advance Care Planning tools in Nevada
 - Supported Decision Making new
 - o Healthcare Power of Attorney Uniform Law in place
 - o Special Dorm Power of Attorney for Dementia
- Supported Decision Making (SDM)- NRS 126C- must have two signers and be informative of what can and cannot be done.
- Power of Attorney (POA) Updates Clarifying the process for determining incapacity – NRS 162A.810 – Time at which POA is effective.
- Placement preferences was also added. Using the Expression of Intent concerning living arrangements. A person cannot be made to go to a locked facility if it is against their wishes.
- Special Form POA for Dementia was added in 2019, NRS 162A.870 with straightforward language.
- Guardianship is the most restrictive. Covers children and adults who are incapacitated and disabled.
- Chuck Duarte motioned to approve letter of support for grant funding, Dr. Jennifer Carson second the motion, all approved.
- 5. Presentation from Healthcare Quality and Compliance (HCQC) on regulation changes related to Alzheimer's and dementia:

Tina Leopard, Health Facilities Inspection Manager, HCQC

- Revised Proposal regulation LCB File No. R043-22 addresses requirements concerning person centered training for employees relating residential facilities/group homes.
- A small business impact study and workshops are being done to get feedback on what the impact will be to businesses.

- Some terminology was updated with help from the Alzheimer's Association.
- Definitions for Tier 1 basic and 2 dementia care required trainings.
- Tier 2 has several allowable places trainings can be obtained.
- Information will be posted on HCQC's website later.
- Language is being adjusted throughout the regulation.
- Section 34 outlines license requirement.
- Assessments are made yearly to determine endorsements.
- Section 35 has additional endorsement requirements.
- Section 36 has additional training requirements for Tier 2 facilities.
- Public comment will be held at a public workshop after the small business impact study has been completed.
