- Jennifer Richards, Esq., Chief Rights Attorney:
 - Nevada has a specialized power of attorney for individuals with dementia in a simple format.
 - To access a cloud based lock box a provider must become an Authorized Entity to gain access and completed the <u>Authorized Entity</u> Access Agreement
 - Lock Boxes can hold Legal Power of Attorney documents along with other legal documents that attorney's, doctors, hospitals, and other authorized entities.
 - NRS 449A refers to Care and Rights of Patients which include surrogates' decision making in Nevada.
 - In 2017 the Nevada Supreme Court did a civil legal needs study; it was determined that providing access to advanced directives could save as much as \$18 million.
