- An individual can revoke a Power of Attorney (POA)
- A POA is limited in scope and would need a judicial determination to allow someone to be placed someone in a locked setting.
- A judge is the only one that can determine capacity and deem a person eligible be placed in a locked setting.
- Having a duty to care for a person may need to have a guardianship put in place to help resolve unsafe situations.
- Fill-in File Wizard forms are available online for filling for guardianship.
- Ensuring residence have the proper paperwork on file will help protect facilities as well.
- Important to get the word out of the process of guardianship.
- The Medicaid Agency, Division of Healthcare Financing and Policy and the Focus Unit could all be potential partners.
- The Nevada Supreme Court has a grant that will help develop materials and trainings for quardian.
- Self Help centers and online service are available for not fees.
- Need training for family and public guardians to have trainings on caring for a person with dementia.
- All approved with one addendum to add education to the proactive indicator.
