- 4. **Presentation and Discussion:** Advance Care Planning, Subjects may cover:
 - Nevada laws/regulations regarding advance care planning
 - All 50 states subscribe to the uniform Power of Attorney (POA) law which may look different in each state.

- Nevada's POA laws have been amended many times over the years.
- Recommendation to have a Physician Orders for Life Sustaining Treatment (POLST) in place.
- The supported decision-making agreement is a tool for older adults that may be diagnosed with dementia. It is a standalone advanced planning document that has legal requirements to complete.
- You can use a POA as a backup to the supported decision-making agreement.
- The Advanced Psychiatric care directive is overlooked and underused by those who may have a co-occurring psychosocial diagnosis.
- Advance Psychiatric care directive does need to be kept updated.
- POA is a power over another individual, supported decision making is the person is still making the decision with support.
- Legal strategies to minimize the need for guardianship.
 - Before guardianship is put in place the individual must demonstrate that it is necessary, and they cannot complete basic needs without assistance being in place.
 - Assembly Bill (AB) 414 changes the language to be user friendly. It expands on priorities like what is very important, somewhat important, and not important at all.
 - Placement clarity is lacking with the special options powers check box section.
 - The new law removed the need for a certificate of capacity which could lead to abuse and exploitation for older adults.
- Efforts by Legal Aid (as an OAA grant recipient) to offer advance care planning resources (service/education) including the Legal Aid kiosk project.
- Assessment of unmet needs related to advance care planning (services/education)
- Potential new/revised legislation for the 2025 legislative session.
