 - The goal is to one day have a DSS in every county
 - The DSS will be in one region but will be assigned to cover only one county.
 - Rural counties that have a Dementia Friendly Nevada effort will have a better chance of getting a DSS at this time.
 - The DSS will be employed by different Nevada Care Connection Resource Center.
 - $\circ~$ It is anticipated that the Pilot program will possibly launch in January 2025.
 - The Legislative action on this recommendation is to secure funding in the state budget to support the expansion of the DSS program to every county in Nevada.
