- It was recommended all individuals attend the SB78 hearings and speak on how they feel about the matter of the combined commission. Not as a representative of TFAD but as separate entities.
- LeeAnn Mandarino motioned to present the reasons for the opposition to the new policy to at the full TFAD, and to put forth a letter of explanation to be sent to the Department of Business and Industry and the Governor.
