- Dementia Friendly Pyramid Lake Paiute Trib advisory group recently partnered with the Dementia Engagement, Education, & Research (DEER) program to host a Nevada Tribal Summit on age and dementia friendly care.
- 89 people represented 12 different Nevada tribes.

- 6. **For Possible Action:** Identify, Discussion, Review and Potential Vote of Approval on Bill Draft Request (BDR's) and Assembly Bills (AB's) affecting people with Alzheimer's/ Dementia.
 - AB338 Revises provisions relating to health care for seniors
 - Declared Exempt
 - o Currently in Assembly Ways and Means after policy hearing.
 - AB337 Creates programs related to dementia
 - Declared Exempt
 - o Currently in Assembly Ways and Means after policy hearing.
 - Overview of <u>Senate Bill (SB)78</u> Amendment and future Proposed Revised Provisions relating to Boards, Commissions, Councils and Similar Bodies.
 - It is in the Senate Finance Committee with an amendment to reduce the scope to only occupational boards.
 - Nevada B&I mentioned they will want to address advisory boards in the next legislative session.
 - The Governor sets the budget based off December Economic Forum projections.
 - The Legislature then works to approve the final budget based on the Governor's Recommended Budget. Then uses the final May projects of the Economic Forum to finalize the budget. .
 - The first time since 2009 the May projection from the Economic Forum is less than the projection in December to the amount of \$190 million.
 - An additional \$160 million shortfall for education for a total of \$350 million.
 - The state has seen a lack and decline in tourism with a reduction in sales tax.
 - No additional programs outside of the current ones will be supported.
 - No new positions and vacancies may help with the shortfall gap.
 - Proposals that hold a fiscal note were cut from the Governors bill.
 - Enforcement on citizenship and making sure only legal permanent residence are getting funds.
 - Potential cuts to Medicaid can/will affect the state budget and programs.
 - Current Older American Funding ends September 30,2025.
 - A 12% cut did include Fund for Healthy Nevada, Independent Living Grants which was approximately \$1 million.
