Dr. Borson is a professor at the University of Washington School of Medicine, Psychiatry and Behavioral Sciences BOLD Center for Excellence of Early Detection on Dementia. Dr. Borson developed the Mini Cog, which is a brief screening tool for cognitive impairment designed for use in primary care and non-specialist settings.
