POSITION DESCRIPTION

Aging and Disability Services Division (ADSD) is recruiting for multiple Developmental Specialist 2 positions within Nevada Early Intervention Services (NEIS) and Autism Treatment Assistance Program (ATAP) Program for Carson City, Nevada.

Developmental Specialist develop and implement programs and treatment and service plans, provide direct services and case management, develop financial and community resources, and provide education, information and technical assistance to family members, other agencies and service providers regarding human growth and development. SPECIAL REQUIREMENTS: A valid driver's license is required at time of appointment and as a condition of continuing employment. Some positions must obtain an endorsement in Early Childhood Special Education issued by the Nevada Department of Education, or a comparable certification issued by the Nevada Individuals with Disabilities Education Act (IDEA) Part C office within three years of appointment to this series or a comparable certification. (This license requirement applies only to those positions directly involved with children from birth to eight years of age with developmental delays.)
