## SOCIAL WORKER 2

### POSITION DESCRIPTION

Aging and Disability Services Division (ADSD) is recruiting for multiple Social Worker 2 positions within Community Based Care (CBC) and Adult Protective Services (APS) Programs for multiple locations in Nevada.

Social Workers are licensed professionals who provide case management services to children, families, the elderly, and other individuals within local communities and institutions. The social workers within our agency may support Nevada's frail older adults and people with physical disabilities to remain independent in the community and prevent long term care placements. Additionally, be responsible for assisting vulnerable adults, age 18 to 59, in addition to persons 60 years and older who are abused, neglected, exploited, isolated, or abandoned by investigating, providing, or arranging for services to alleviate and prevent further maltreatment while safeguarding their civil liberties.

Under direction, Social Worker II's perform journey level case management services. This work requires the application of principles of the social work profession. Crisis intervention and objective evaluation may require incumbents to encounter potentially hostile and combative individuals. Social Worker II's perform the full range of duties described in the series concept at the journey level. This position is full time and is under the direction of a Social Work Supervisor.

### MINIMUM QUALIFICATIONS

**EDUCATION AND EXPERIENCE:** Licensure or provisional licensure as a Social Worker, Clinical Social Worker, Independent Social Worker or Associate in Social Work and one year of professional experience providing case management in a social work setting equivalent to a Social Worker I in Nevada State service. **SPECIAL REQUIREMENTS:** A valid driver's license is required at time of appointment and as a condition of continuing employment; some positions are subject to call-out or call-back; some positions require work on evenings, weekends, and/or holidays; licensure or provisional licensure by the State of Nevada Board of Examiners for Social Workers as a Social Worker, Clinical Social Worker, Independent Social Worker, or Associate in Social Work is required at the time of appointment and as a condition of employment.
