#### 3. Presentation and Discussion: Draft Olmstead Plan

Title II of the ADA mandates public entities to provide integrated living spaces for people with disabilities. The Olmstead v. L.C. decision (1999) reaffirmed this obligation and encouraged the creation of 'Olmstead plans' to support community integration efforts. This plan will guide ADSD in ensuring an accessible person/family centered State system that provides services where and when they are needed. ADSD understands that achieving sustainable change for all of Nevada's residents who have a disability and seek opportunities within communities of their choice will require partnerships and efforts that are beyond the scope of the State service system. Because of that, this plan will explore the variety of supports needed by Nevadans with a disability but will focus its action on what ADSD has the authority to implement.
