ADSD Notice of Funding Opportunity Q&A – Nutrition – FY26

Q1: I will not be able to attend the informational meeting and wondered if you could let us know if there will be an increase in the reimbursement rate this year?

A1: Currently there is not an increase in the reimbursement rate for FY26. Typically, ADSD evaluates reimbursement rates during funding decisions. Other times, state or federal mandates may dictate fluctuations in the reimbursement rate. If it is determined that the reimbursement rates for congregate and/or home delivered meals will change in FY26, ADSD will provide this information as soon as possible.

Q2: Is this award just for prepared food or can applicants also do home delivered groceries? A2: This NOFO is for congregate or home delivered **meals**. This funding does not support grocery deliveries. ADSD does have other funding sources that may support grocery delivery. The next competitive NOFO with funding that may support grocery delivery will be for SFY27.

Q3: Does this NOFO pay for food, or just the service/staff to get the food in to the community? A3: Organizations are able to request additional expenses that support meal service and delivery, including staff.

Q4: Can other ages be serviced or is this just for seniors 60+? The money is just for the food, expenses?

A4: Other individuals that can receive meal service include spouses (for congregate or home delivered meals), organization volunteers, or persons with a disability living with a senior who is receiving home delivered meals.

Q5: AOR - Does a current "Delegation of Authority" letter authorize an authorized signer to sign and submit the application?

A5: No. "Delegation of Authority" letters are good for one calendar year from the date of the letter. Letters are usually submitted due to changes in delegation or other occurrences that happen within the funding year. AORs must sign the application and can list authorized signers on the application.

Q6: Also, just a note the NOFO wasn't sent to list serve until 1:10 pm today, which may be why attendance might be low. I was not prepared to be on the call today, so unfortunately, I can't stay. I look forward to seeing the answers posted!

A6: The NOFO was distributed by email and posted on ADSD's site on Friday 7/18/2025. It was distributed through three separate emails due to the quantity of recipients. We were notified today by a subrecipient that they had not received the email. That email was resent at 1:10 pm today. We apologize for this inconvenience and appreciate you joining today.

Q7: Email Submissions: will we receive an automatic reply/response to confirm receipt of our application?

A7: Yes, you will receive an automated response from our ADSDGrants mailbox. If you do not, please resubmit or contact one of the Nutrition Program Coordinators to inform of the issue so we can troubleshoot.

Q7a: Is this new? I do not receive automated responses.

A7a: If you submit an email directly to the ADSDGrants mailbox and do not copy others, an auto response is generated. If you copy others (Cc and/or Bcc) the auto response may not generate.

Additionally, auto responses can be caught by an organization's email security system and/or spam filter.

- It is recommended when submitting items to <u>ADSDGrants@adsd.nv.gov</u> that this email address be the only recipient. If others need to receive the email you can forward it to them.
- If you do not receive the auto response it is recommended that you resend the email to ADSDGrants@adsd.nov.gov as the only recipient.

Q8: How should we cite our work in relation to data and statistics or other relevant research stated in our narrative? For example, a footnote at the bottom of each section in the narrative, or an attached page listing works cited, etc.

A8: You may use either method to cite references.

Q9: Can Requests for Reimbursement (RFRs) be submitted quarterly? Or do they have to be submitted monthly?

A9: Effective for 2026 subawards, RFRs must be submitted monthly.

Q10: Can we apply for both programs on one application? Or do we have to apply for Congregate Meals and Home-Delivered Meals as 2 separate applications? A10: Congregate Meals and Home-Delivered Meals are 2 separate and distinct programs with different funding sources. You may apply for one program or both programs. Each program requires a separate application package (all required forms).
